I teia ngauru mataiti e tu mai nei, ka na roto tatou i tetai akakeuanga akameitaki i te turanga o te apii ki runga i te au enua katoatoa o te Kuki Airani. Na roto i Nga Mato o teia parani – Tupuanga Ngateitei, Aratakianga e te Akatereanga Ngateitei, Kaveinga Rangatira – ka kimi matou i te ravenga kia rauka i te oronga i te apianga tau te ka akamaroiroi i to tatou iti tangata e kia riro te Kuki Airani ipukarea rangatira ki roto i te tuanga apii.

Ko te apii te papa tumu tei riro ei vairanga no te mou e te oraanga memeitaki o to tatou ipukarea. Ka riro i te akakeu i to tatou iti tangata, utuutu i to tatou kapuaanga maori e ka akangarepu katoa i te karape tukeke tei vai ki roto i to tatou iti tangata Kuki Airani. Ia tatou e akara atu nei ki teia tau ki mua, kia nakiro katoa tatou i te tuanga puapinga ta te apii ka rave i te rapaanga i te kaveinga o to tatou ipukarea.

I raro i te Mato o te Tupuanga Ngateitei ka akanoo matou i tetai tuanga Apii Potiki matutu e te maoraora, ka akaepaepaia to tatou tupuanga iti tangata e ka akamouia ki runga akaoraanga i te reo, te peu, te akonoanga e te irinakianga Kuki Airani, ka taparu, ka tereniia e ka tereni akaouia te au taunga apii i te au ravenga tukeke e ka atuiia mai te tangoanga i tetai puakapa terenianga puapii, te akamatutu i te revera o te karape numero e te tatau e te au tuanga katoatoa ki roto i te au apii katoatoa o te ipukarea.

Te Mato 1 Akatauangaanga e te Turanga Ngateitei.

Pillar 1: Learning and Educational Excellence

This pillar is central to achieving SDG 4: Quality Education, which aims to ensure inclusive and equitable quality education and promote lifelong learning opportunities for all. The goals and objectives under this pillar focus on:

- **Akapapuanga i te Apiianga e te Akatauangaanga Tau - Ensuring Quality Teaching and Learning:** By improving educational standards, curricula, and teaching methodologies, we are working towards SDG 4's target of ensuring that all learners acquire the knowledge and skills needed to promote sustainable development.
- **Akapararauareanga i te Kapuaanga Maori e te Apiianga Akaruru - Promoting Cultural Identity and Inclusive Education:** Our commitment to revitalising Cook Islands Māori and fostering inclusive education directly supports SDG 4.7, which focuses on ensuring that all learners acquire knowledge and skills needed to promote sustainable development, including through education for sustainable development and sustainable lifestyles.
- **Akanekeanga ki te Akatauangaanga Ngateitei - Advancing Higher Education:** By aligning tertiary education with local and global workforce needs, we support SDG 4.3, which calls for equal access for all women and men to affordable and quality technical, vocational, and tertiary education, including university.

Quality Early Childhood Education and Lifelong Learning

- **Objective 1:** Establish a responsive Early Childhood Education system with consistent pedagogical practices and a comprehensive curriculum.

2. The rich cultural heritage and language of the Cook Islands will be honoured and celebrated through effective immersion programmes and inclusive education practices, ensuring that all students gain a deep appreciation of their cultural identity.
3. The education system will attract, train, and retain highly skilled teachers, supported by continuous professional development opportunities and strengthened governance and resource allocation, leading to improved teaching quality across the country.
4. Numeracy and literacy levels will rise across the nation due to the implementation of evidence-based programmes and interventions. School facilities and resources will be regularly assessed and upgraded, maintaining high educational standards.
5. Leadership within the education sector will be strengthened through the development and implementation of targeted leadership training programmes, the establishment of a robust mentorship and coaching framework, and the fostering of a culture of continuous professional growth among educational leaders.
6. Higher education will be advanced to support workforce development by reviewing and updating tertiary education programs to align with local and global job markets, developing industry partnerships to address workforce demands, expanding access through flexible learning options, enhancing digital literacy, and investing in modern infrastructure and technology. Ongoing professional development for tertiary staff will ensure high standards in teaching, research, and leadership.
7. An inclusive education system that supports all learners will be established by developing tailored educational programmes and resources for students with special learning needs and those facing physical, social, or developmental barriers. Educators will be trained in inclusive teaching practices, and school infrastructures will be enhanced to ensure accessibility and support for all students, promoting equal opportunities for educational success.

ensuring Early Childhood Education from 0-5 years is fully integrated into the education system, and the transition from ECE to Year 1 is optimised.

Standards and regulations for Early Childhood centres will be developed and regularly reviewed, ensuring high-quality early education across the Cook Islands.

Stakeholders will be actively engaged in the policy development process, ensuring that policies remain relevant, inclusive, and responsive to the evolving needs and trends of the education system. This will enable the Ministry to adapt effectively to changing educational demands at all levels, from early childhood through to tertiary education.

An effective communication strategy will facilitate transparency and engagement with the public, parents, and stakeholders, promoting awareness of educational initiatives and fostering a culture of openness and accountability.

A dedicated team will research and analyse global educational trends and innovations, implementing pilot programmes and providing professional development opportunities. This will ensure the Cook Islands' education system remains innovative and forward-thinking, particularly in areas such as technology integration and cultural preservation.
